Annual Business Plan and Budget Summary

The District Council of Yankalilla's 2022/23 Annual Business Plan and Budget was adopted at the Special Council meeting held 12 July 2022.

Mayor's Message

Since the preparation of the Draft Annual Business Plan & Budget 2022/23 for consultation several changes were identified that needed to be considered before Council adopted the final Annual Business Plan & Budget 2022/23 on 12 July 2022.

In the Draft Annual Business Plan & Budget 2022/23 an estimate of inflation of 4% was assumed, this has proved to be too low. Inflation has risen significantly, with the March figure being 4.7%. The assumption for growth used in the budget was 1.35%, however, the actual figure is 0.9%, this has been adjusted for in the calculation of Rates Revenue in the budget.

The Normanville Foreshore project has experienced increased material costs and design changes which have led to the expected costs increasing by \$403,000.

The Jetty Caravan Park Cabins project budget has increased by \$872,000 due to multiple changes in the overall design and project. Due to the complexity of the project, several delays have occurred with the budget being based on an opening date in early December 2022.

The timing of payments required to be made by the Council for the Combined rebuild of the Surf Life Saving Club & Café/Kiosk has been clarified and it is now budgeted for the \$1.155m to occur in the following financial year, 2023/24 and this is included in the Long Term Financial Plan.

I'd like to thank the 67 people who participated in our Community Engagement process who provided feedback on what projects were supported or not supported, rate rises, and debt levels which helped us prioritise our proposed projects whilst working within the goals of our Long Term Financial Plan.

Elected Members having considered community feedback have tried to keep the Rates rise as low as possible while maintaining sustainability, resulting in an average Rates rise of 5.5%. The Council has made some difficult decisions to reduce expenditure, defer projects, and allowed for the rapidly increasing level of inflation so we can continue to maintain the expected level of services to the community and remain financially sustainable. The changes we have made to the plan have positively resulted in our Net Financial Liabilities Ratio now forecast at 94% for 2022/23, much lower than the figure that was included in our draft plan.

The list of projects included in the budget is listed overleaf under Major Project Highlights in 2022/23.

It is an exciting time as we now continue the construction phase of our major projects that have been years in the making and will be enjoyed by future generations.

The budget changes the Long Term Financial Plan's previous 2022/23 forecast deficit of \$88,000 to \$437,056.

Revenue is expected to increase significantly from our Council owned Jetty Caravan Park following the completion of the installation of 23 new cabins.




Our Framework for Delivery

Seniors (holding a State Seniors card) can apply to Council to postpone payment of a proportion of rates on their principal place of residence.
