Over \$2 Million in Grant Funding Secured

Council has secured \$2,045,450 in grant funding from the State Government's Local Government Infrastructure Partnership Program for improved visitor accommodation at the Council-owned Jetty Caravan Park Normanville.

The project will deliver 23 higher quality cabins as a standalone component of a broader masterplan for the Normanville Foreshore.

Mayor Glen Rowlands said, "Unlike many infrastructure projects, tourism infrastructure has the added benefit of offering a return on investment." "This project will have the effect of generating income to offset reliance on rate revenue to service loans and fund projects across the whole district, adding an element of ongoing sustainability to this \$4,090,900 project, with Council contributing 50% and grant funding covering 50%."

Cr Simon Rothwell said, "It's an

exciting time for the District Council of Yankalilla on successfully achieving the largest grant in Council's history, good planning achieves great outcomes."

Cr David Olsson said, "The injection of this significant stimulus funding by the State Government will enable our district to enhance capital improvement in the Caravan Park as part of the masterplan and stimulate local employment."

The project will promote local materials and labour as a priority for its local economic recovery. It is anticipated that during the construction period 5 local jobs will be generated and 11 jobs more broadly through multiplier effects. Tourism is a labour-intensive industry, growth in its economic contribution produces more jobs per dollar than most other industries.

Cr Leon Zarins said, "In these unusual and difficult circumstances I am

pleased that we are able to obtain funding to further develop and promote our beautiful community."

Cr Peter O'Neil said, "The success of our grant funding application is a GAME CHANGER, I say watch this space". "Yankalilla's district financial fortunes are changing in \$2million positive ways."

Work continues on the Normanville Foreshore and Jetty Caravan Park Draft Masterplan which will be presented for consideration at the 20 April 2021 meeting of Council.

"Receiving the Local Government Infrastructure Partnership Program grant now brings the secured external funding to a total of \$4,700,500 towards Masterplan projects and we eagerly await the results of other funding opportunities we have applied for", said Mayor Glen Rowlands.

CEO's Corner

Ask the CEO (Nigel Morris)

Q1: As a small Council area Yankalilla has some of the highest rates in South Australia. As a rate payer who visits rather than lives in the area we get less value for our rates than permanent dwellers. I note that the foreshore development will generate extra funds of some \$600,000 per annum for the Council owned caravan park. Can you confirm that all this additional revenue will be channelled in to the debt Council incurs for the development? I believe our rates are already too high and do not wish to see increases due to the development which I am in favour of. - Mark

The investment in additional cabins in Jetty Caravan Park is expected to return significant income to Council.

The recent report to Council's March meeting (Council-Agenda-16-March-2021) showed various scenarios with regards to the long term financial forecasts both with and without the investment at the caravan park.

Additional income from the caravan park would enable Council to reduce its debt significantly faster. The forecasts show a level of debt 17% lower at the end of the forecast period if the Normanville foreshore projects proceed (including the cabins at the caravan park) than if it does not.

Q2: I understand that The Local Government Act requires the disclosure of allowances and disbursements made to councillors. When does our council make this disclosure, and where is it available publicly? – Don

Under Section 79 of the Local Government Act 1999 we are to provide access to the Register of Benefits and Allowances, for inspection and purchase, at the principal office. This register is kept at the front counter, and available for viewing upon request, and is updated annually at the end of each financial year.

Q3: When does Council expect to receive a response from DIT on the pedestrian refuge proposal recently out for consultation and for which there was overwhelming support? If accepted, when is the project likely to be funded and completed? If the submission to DIT is not accepted, what are Council's plans to meet this urgent need? – Doug

Council at its meeting held January 2021 resolved to write to the Department for Infrastructure and Transport (DIT) indicating its support for the proposed pedestrian refuge and provide DIT with all community feedback responses.

In the covering report presented to Council it provided the following information from DIT:

- There is currently no funding for any work at this location.
- Prior to any funding bid being submitted for a refuge, consultation will need to be undertaken to determine the community and Council's support for the project.

Given that Council has now provided ours and the community support for the project the next stage is for

DIT to secure funding. The State Government budget process is provided at the following link: www.treasury.sa.gov.au/budget/process-development-And-monitoring

Council is likely to hear from the State Government as they progress their budget cycle.

As this section of road is owned by DIT we await their work on their infrastructure.

As a positive sign, I did see them out marking up the services on the road in preparation for the project.

Q4: It is clear that Little Corellas are inflicting significant damage to trees, sporting facilities, school premises etc in Yankalilla and the noise created by them significantly impacts the peaceful enjoyment of summer in the township. What action does Council intend to take? – Doug

This is a state-wide issue that we continue to work with the State Government towards a resolution. I encourage you to attend the 6 April 2021 Elected Member Forum at 4pm to hear direct from State Government on their approach.

Council is a member of the South Australian Regional Organisation of Councils (SAROC), in February 2021 a report was released on the issue to detail how as a collective of Councils we are dealing with the issue.

Council will continue to work towards a state-wide approach as dealing with this in isolation will not solve the problem.

Council Decisions

The following will provide a summary of the March 2021 Council Meeting decisions. As always, we encourage you to read the complete agenda and minutes to get the details and a greater understanding of topics at www.yankalilla.sa.gov.au/council/agenda-and-minutes

Mayor's Report

The Mayor's Report was received noting the community attendance at Normanville regarding the beach access for watercraft and the attendance at the Scout awareness session.

Deputations

Council heard from Mr Drony who voiced his concerns with the draft Long Term Financial Plan. Mayor Rowlands also reported that he refused a deputation from Mrs Gubbin as the topic of request was not a matter on the Agenda, however he encouraged the deputation at a later date when parking matters are to be discussed.

Questions on Notice

Several questions were raised by Cr. Verwey in relation to the Normanville and Jetty Caravan Park Masterplan such as details of meetings held with the Chief Executive and Competition with Private Sector and Concept Plans. Detailed responses, including maps, were included in the Council Agenda and Minutes and are available on the website.

Cr. Christie sought information on the internal rate of return for the new Normanville Surf Life Saving Club, Kiosk and proposed cabins at the Jetty Caravan Park. The expected rates of return were detailed in the Chief Executive's responses.

Cr. Christie asked for information to be provided on the Divisions that have been called at Council meetings, during the term of the current Council, from November 2018. A total of 43 Divisions have been called during this period and were individually listed in the Chief Executive's response.

Motions on Notice

Cr. Christie moved that the Chief Executive provide a report to the May 2021 Council meeting on what

measures are being considered by other councils, the LGA or ALGA, and both State and Federal governments to manage the negative community impacts caused by short term holiday rentals directly or indirectly. This motion was not agreed upon and therefore lost. There will be no action taken on this matter.

Reports

Chief Executive Report

The detailed monthly Chief Executive Report outlining matters occurring during February was received. Council resolved:

- That the next steps for consultation on the New Library design be a topic of discussion at the 6 April 2021 Elected Member Forum.
- That the Normanville Foreshore and Jetty Caravan Park Masterplan be presented to the 20 April 2021 Council meeting for consideration.

Council Committee Minutes

The following Minutes of Council Committee meetings, available on Council's website, were received:

Public Art Policy

The revised Public Art Policy was presented to Council in February and it was resolved to hold further discussions at the March Elected Member Forum to make required amendments. The Policy was updated and adopted at the March Council meeting.

Myponga School Way2Go Recommendations

The Myponga Primary School are participating in the Way2Go program facilitated by the Department of Infrastructure and Transport. Investigations were carried out at the school and recommendations for safer travel to and from school for students were presented to Council. The implementation of the improvements will be included in the development of the 2021/2022 Annual Business Plan.

New Planning, Development and Infrastructure Act

The new State Planning System will be implemented from 12.01am on Friday 19 March 2021. New Fees and Charges will apply, to those applicants seeking Council's assistance to carry out requirements such as lodgement and public notification.

Under the new Planning, Development and Infrastructure Act, Council as a Designated Authority and Entity were delegated powers and functions to exercise under Sections 44 and 101 of the Local Government Act and section 100 of the Planning, Development and Infrastructure Act. All powers and functions are delegated from Council to the Chief Executive who then sub-delegates these to relevant qualified staff.

Mid Year Budget Review 2020/2021

Budget Reviews are carried out quarterly, outlining Council's current financial position and adjustments are made where required. The following was resolved at the March meeting:

1. That Council adopt the 2020/21 Mid-Year Budget Review adjustments as follows:

Long Term Financial Plan 2021-2030, including Normanville Foreshore and Jetty Caravan Park Masterplan Risk Management Plan, Risk Matrix and Dependencies

Council's Audit Committee made recommendations to Council after reviewing the draft Long Term Financial Plan 2021-2030 noting a sound process had been undertaken to estimate the cost of cabins using an external consultant. Council noted the Audit Committee's recommendations and resolved to adopt the Long Term Financial Plan 2021-2030 as the current LFTP and resolved to prepare a Prudential Review to include the Normanville Foreshore and Jetty Caravan Park Masterplan.

Treasury Management Report

Council's Treasury Management Report was received.

Subsidiary Charter Reviews

Council approved the revised Fleurieu Regional Waste Authority Charter 2021 and the revised Southern & Hills Local Government Association Charter 2020.

Delegations for Council Powers and Functions

The Local Government Association recently made amendments to their delegations framework, prompting Council to undertake a full review of its delegations. Council resolved to revoke all previous delegations under 54 legislative Acts and Regulations and granted the delegation of powers and functions to the Chief Executive under 66 legislative Acts and Regulations. These powers and functions will be sub-delegated to relevant qualified staff.

Regional Subsidiaries and other Organisations/Entities

The following minutes of meeting were received:

- Southern & Hills Local Government Association – 11 December 2020
- Fleurieu Region Community Services Advisory Committee – 9 February 2021

Other Business

Council previously resolved to leave the consultation channels open

for feedback on the Normanville Foreshore and Jetty Caravan Park Masterplan and for Administration to provide an updated of feedback received at each Council meeting. An updated Engagement Report including 12 new submissions and additional correspondence from 4 ratepayers who previously lodged submissions, was provided in the Council Agenda.

Mayor Rowlands mentioned other Councils are offering to compensate local SALA entrants, assisting with part payment of fees. This will be discussed at a future Elected Member Forum.

Mayor Rowlands also advised that the sale of Lot 301 Brown Road, Carrickalinga had not yet proceeded and would be a topic at the April 2021 Elected Member Forum.

Right and left turns from Williss Drive to Main Road and Main South Road will remain the same and need to give way to all oncoming traffic.

New left turn lane for traffic turning left into Williss Drive from Main South Road. Traffic will no longer have to give way to traffic coming from Main Road

Other proposed treatments:
 • Removal of one tree
 • Upgraded LED lighting for the extent of the project.

Williss Drive Intersection Safety Improvements

The Department of Infrastructure and Transport (the Department) will be improving safety and traffic efficiency at the junction of Main South Road, Main Road and Williss Drive, Normanville. This \$300,000 project is being delivered by the State Government to improve safety for all road users.

The project will include:

- The installation of a left turn lane for traffic turning left into Williss Drive from Main South Road.
- Upgraded LED lighting for the extent of the project.
- The removal of one tree.

Major construction works are scheduled to commence on 9 March 2021 with completion expected in May 2021, weather permitting. No works will be undertaken during the April school holidays.

The rest of the works will occur during the day between the hours 7am and 5pm, Monday to Friday.

Works will be undertaken to:

- Ensure the safety of road users, pedestrians and construction workers
- Minimise impacts to traffic during the day
- Complete the works as safely as possible

The intersection will remain open to traffic during works, with speed restrictions in place while workers are on-site. Lane and other speed restrictions may apply subject to onsite conditions. Motorists are advised to take care when driving through the area.

Construction is well underway on the Rapid Bay Ford Crossing Replacement and is expected to be completed by early June 2021. Council has received joint funding under the Federal Government

Bridges Renewal program to upgrade the existing ford crossing at Rapid Bay. A new higher-level crossing is being constructed immediately upstream of the existing crossing.



Fleurieu Tap Water Change Improves Quality and Taste

A new, high-quality tap water supply is now flowing to SA Water customers in Yankalilla, Normanville and Carrickalinga, as part of efforts to improve drinking water for the Fleurieu Peninsula.

Starting from Wednesday 17 March, the final disinfection process applied to cleaned and filtered drinking water sourced from the Myponga Reservoir has changed from chlorine to chloramine.

SA Water's Senior Manager of Water Expertise and Research Dr Daniel Hoefel said residents are receiving the same improved water quality already provided to Myponga, following the township's supply switching to chloramine in 2018.

"Although it's a matter of individual preference, some people may notice that tap water disinfected with chlorine has a distinct smell and taste, and chloraminated water

lessens this effect," Daniel said.

"Some of our best-tasting and award-winning tap water provided to towns like Morgan, Keith, Port Pirie, Clare and Whyalla is disinfected with chloramine. The change from chlorine to chloramine will ensure the Fleurieu's water remains clean and safe to drink, but with a slightly different and improved flavour profile."

"Some customers may temporarily experience discoloured water through their taps as a result of the change over to chloramine as organic matter is stirred up through the pipe network, however this is normal and your tap water remains safe to drink."

Myponga Reservoir is Opening for On-water Access for Kayaking and Fishing

For the first time, on-water access for kayaking and fishing will be allowed at Myponga Reservoir from 28 March, adding to the current land-based recreational activities available such as walking and cycling.

Minister for Environment and Water David Speirs said, “the reservoir is part of the Marshall Liberal Government’s ‘Opening up our Reservoirs’ policy which aims to create new open, green space for people to explore, drive increased tourism and create jobs”.

“To have improved access to Myponga reservoir just in time for Easter will be a timely boost for the Fleurieu Peninsula communities”.

“More than 150,000 people have visited our reservoirs since we started opening them for recreational access and to be able to offer on-

water access at Myponga will attract a whole new range of visitors to the region”.

“The increase in visitor numbers has been a big boost to our regional economies and businesses in Myponga and have reported a significant upturn in activity”.

“Protecting the health and quality of our drinking water supplies remains the priority and this has been possible thanks to improved water treatment plants, detailed water quality risk assessments, as well as increased site security and water quality control measures”.
