It has been a busy month with budget discussions, assessing community feedback and finally adopting a budget at the Special Meeting on 12th July.

I attended the Lions Hand Over dinner again with numerous awards presented and a new board elected. They are a proactive group with successful projects such as the Yankalilla Classic Motor Show.

There has been some misleading information circulating, about myself in reference to conflict of interest, due to my involvement in the Aldinga Bay Surf Life Saving Club (SLSC) within the Onkaparinga Council area. I would like to clarify that I have had legal advice, advising that I do not have a material, actual or perceived conflict of interest on matters relating to the Normanville SLSC. I have decided to declare a perceived conflict of interest, erring on the side of caution, in matters relating to the Normanville SLSC.

I have also had a ruling by the Ombudsman, who did not consider I had a material or actual conflict of interest on matters relating to the Normanville SLSC but agreed that I should declare a perceived conflict of interest on such matters. I am able to debate and vote on these matters.

I am hoping this clarifies some confusion on this matter.

Monday 11th July the Interim CEO, Kate O'Neill and myself had the pleasure of taking Her Excellency the Honourable Frances Adamson AC on a tour of our district. We started with a tour of Fleurieu Milk followed by a walk in the Myponga Reservoir inspecting the launch facilities and infrastructure. Local Landcare Legends

This month's local Landcare Legends are a relatively new one – the Friends of Wirrina Landcare Group.

Wirrina Cove is an area with significant beauty and conservation value. Wirrina was a traditional meeting place for First Nations before European settlement. It encompasses differing topographies including coastal frontage, steep cliffs, creeks, plus a large body of open freshwater servicing the needs of the Wirrina community. There are also some small patches of remnant vegetation. It is home to many birds and animals and provides habitat for a number of threatened species on the Fleurieu Peninsula.

The site the group helps manage is made up of 32 hectares of Yankalilla Council owned land and is currently planted out with approximately 25,000 plants from previous Landcare projects, including a Conservation Volunteers Australia (CVA) project funded through the "20 Million Trees" project.

The goal of this mass planting was to enhance the potential for the endangered glossy black cockatoo to have suitable foraging material locally and to act as a stepping stone for this species to come across from Kangaroo Island and potentially populate the Fleurieu Peninsula.



The group's aims include building on this previous revegetation work by increasing bushcare knowledge and capacity, maintaining the current plantings through regular working bees and to prepare a site review to identify areas that would benefit from specific ongoing bush care that are accessible and highly visible so as to promote local biodiversity. The plan is to focus the group's efforts for the best overall environmental outcomes.

The Friends for Wirrina Landcare group and its actions are supported by Green Adelaide/Yankalilla Council Coastal Officer Corey Jackson and the Fleurieu Environment Centre. The group are grateful for the support of neighbouring group, the Cape Jervis Coastal Community Group. The mentorship shown by this long standing group showcases the importance of partnerships to share learnings and for passing on hard won technical advice.

Tree Trimming Along Jetty Road

Council is undertaking tree trimming along Jetty Road Normanville to provide a clearance envelope across the full width of the road to allow for the safe passage of legal height vehicles and in accordance with DIT Operational Instructions and Council's Infrastructure Asset Management Plan for Transport. Council wishes to assure the community that no Morten Bay Fig Trees are being removed as a part of these works.

These works will allow for safe passage for the 23 new cabins being delivered to the Jetty Caravan Park over the next few months while also mitigating the risk of future damage to the Morton Bay figs and taller vehicles which utilise Jetty Road.

2022-2023 Rates Notices will be sent soon via email (EzyBill), post or Bpay view depending on your preferred method of contact.

1st Quarter Payments are due by 15 September 2022.

Having difficulty paying your council rates?

If you have (or are likely to have) difficulty in paying your rates, please contact Council's Rates Officer on 8558 0200, before your rates fall into arrears, to discuss options that may be able to assist you.

Payment arrangements and due date extensions can be negotiated with ratepayers who may be experiencing financial difficulties or need to set up weekly/ fortnightly/monthly payments. Persons experiencing genuine ongoing financial hardship may seek assistance from Council where hardship can be substantiated by Certified Financial Counsellors.

These enquiries are treated confidentially.

EzyBill – Receive Rate Notices via email

Receiving rate notices electronically via email makes it easier and more convenient to manage payments, save paper and reduce waste.

Notices are sent directly to your nominated email address and are accessible on any electronic device: phone, tablet, laptop or desktop, as long as you have internet access.

To start receiving your rates notices via email:

- Register your details on the EzyBill website – www.yankalilla.ezybill.com.au
- 2. Complete the registration form, and you will receive an activation email.
- 3. Open the email and select to activate your account
- Register your properties to receive any future rate notices via email.

You will receive your quarterly notices via EzyBill. Overdue Notices and other Council correspondence will only be issued to your postal address, so please ensure you keep your details updated with Council.

Completed Project Updates

Community Land Management Plan for 55A Seaview Avenue Wirrina

The Council after considering the public submissions received in response to the community consultation resolved to not adopt a new Community Land Management Plan for the parcel of land at 55A Seaview Avenue Wirrina Cove and that the parcel of land remains in the Drainage and CWMS Reserve Community Land Management Plan.

Draft 2022/23 Annual Business Plan and Budget

Since the preparation of the Draft Annual Business Plan & Budget 2022/23 for consultation several changes were identified that needed to be considered before Council adopted the final Annual Business Plan & Budget 2022/23 on 12 July 2022.

The Council has made some difficult decisions to reduce expenditure, defer projects, and allowed for the rapidly increasing level of inflation and increasing project costs, so we can continue to maintain the expected level of services to the community and remain financially sustainable. The changes we have made to the plan have positively resulted in our Net Financial Liabilities Ratio (a measure of Council's indebtedness) now forecast at 94% for 2022/23, much lower than the figure that was included in our draft plan.

Elected Members having considered community feedback have tried to keep the Rates Rise as low as possible while maintaining sustainability, resulting in an average Rates rise of 5.5%.

Major Projects

Cape Jervis Boat ramp and Pontoon

The repair works to the boat ramp and installation of the new floating pontoon including a 3m extension have been completed. We are waiting for favourable weather and the barge to be available that they will bring around from Goolwa to complete the final works of installing one more pylon and handrailing.

Forktree Road Sealing

The majority of construction is finished, we are waiting for favourable weather to conduct the final preparation and seal to complete this project. The contractor repaired potholes on Thursday 28th July and will continue to maintain the unsealed surface until sealing can occur.

Library and Carpark

This week saw the roof go on the new Library and now the contractor will begin installing the first layer of external cladding which is a plywood backing then the Colourbond cladding will follow. The internal first fix will commence shortly after that. The Library is aimed to be opened before the end of the year.

The Thomas Street and carpark kerbing and layout are complete, when we have suitable weather the final seal and concrete footpaths works will commence. The installation of raingardens and further landscaping of the area will follow.

Normanville Foreshore

The majority of the kerb and gutter works will be completed, which when onsite allows you to now visualise the expanded recreational space. The nature play structures have been constructed off-site and the nature play and grass area will commence construction soon. Preparation works for the plaza are commencing and exposed aggregate concrete is scheduled to be poured in August. Construction of the boardwalks will also begin in August. Council staff are expecting to commence landscaping and planting works in September, which will include revegetation works to the entrance area along jetty road. Once SA Water complete their required works Council will undertake a reseal of the entire carpark beginning at the Caravan Park entrance later in the project. Stage one of the Foreshore improvement works is scheduled to be completed in October, then the demolition and construction of the combined Surf Club and Kiosk will begin.





Surf Club and Café/Kiosk

Council and the South Australian Fire and Emergency Services Commission (SAFECOM) are progressing with the project. Council at the July Meeting resolved to sign a development agreement between Council and the Normanville Surf Life Saving Club.

Cabins

Construction of the underground services including wastewater, mains water, fire hydrant line, and electrical service in the caravan park has begun. Construction of the cabins has commenced offsite with the first delivery expected before the end of September and staged delivery through to the end of November.

Appointment of Members to Fleurieu Regional Assessment Panel (FRAP) 2022-2024

Council endorsed the appointment of selected members to FRAP for a two year term, commencing on 1 August 2022.

Changes to Council Meeting Venue

Council resolved that all Council or Committee Meetings would be held at Club Fleurieu, until the completion of air conditioning/construction building works in Council Chambers when it is deemed safe to return.

Wirrina CLMP Consultation

Council considered the public submissions received in response to its community consultation and it Council resolved that Council do not adopt a new Community Land Management Plan located at 55A Seaview Avenue, Wirrina Cove.

Surf Life Saving Club Café/Kiosk Development Agreement

It was decided that Council will negotiate with the Normanville Surf Life Saving Club and Café /Kiosk to make minor changes and to sign the Agreement.

Declaration of Prescribed Officers

Council resolved positions within Council that have a level of financial sub-delegation, which may be in addition to other delegations or authorisations to make decisions on behalf of Council, or the Chief Executive Officer, be declared as Prescribed Officers.

Internal Review of Council Decision – Appointment of Reviewer

It was agreed that the Chief Executive Officer be delegated authority to appoint a legal firm to undertake the role of Reviewer in relation to the decision of Council made at its April 2022 meeting.

Consent of Right of Way Over Crown Land

It was resolved by Council that the Right of Way over Crown Land no longer need to consent to the granting of the right of way and authorise the Mayor and CEO to sign the necessary documentation.

Jetty Caravan Park Cabins Project – Services

Council approved negotiation between Neo Infrastructure and the Chief Executive Officer.
